Claimant diagnosed after October 12, 2012 with one of the <u>Cancers</u> added to the list on that date	Two (2) years from the date of diagnosis, but no later than October 3, 2016		
Claimant diagnosed with <u>Prostate Cancer</u> on or before October 21, 2013	October 21, 2015		
Claimant diagnosed with <u>Prostate Cancer</u> after October 21, 2013	Two (2) years from the date of diagnosis, but no later than October 3, 2016		
Claimant diagnosed on or before February 18, 2014 with a <u>Rare Cancer</u> that meets the definition as explained by the WTC Health Program on that date	February 18, 2016		
Claimant diagnosed after February 18, 2014 with a <u>Rare Cancer</u> that meets the definition as explained by the WTC Health Program on that date	Two (2) years from the date of diagnosis, but no later than October 3, 2016		
Claimant's known condition was not on the original list of qualified conditions or subsequent additions to the list but was added to the list after February 18, 2014	Two (2) years from the date the specific condition was added to the list of qualified conditions, but no later than October 3, 2016
